

These are the terms and conditions (the "Terms") applicable to persons ("You" or a "Participant") entering/participating in the Orijin "Make Your Own Future" National Consumer Promotion" (the "Promotion"). The Promotion will run between 12:00:01 am (Nigerian Time) on 1st of February 2019 to 11:59 pm (Nigerian Time) on 1st of May 2019 ("Promotion Period"). By entering the Promotion, You accept these terms and conditions and agree to be bound by them. This competition is hosted by Guinness Nigeria Plc ("Guinness Nigeria" or "Promoter").

## INTRODUCTION

- 1. Promoter. The Promotion is organized by Guinness (Nigeria) Plc ("Guinness" or "Guinness Nigeria" or "Promoter").
- 2. Promotional Period and submission times: This Promotion runs from 12:00:01 am (Nigerian Time) on 1st of February 2019 to 11:59 pm (Nigerian Time) on 1st of May 2019 ("Promotion Period"). For entries to be valid they must be submitted in the stipulated format- SMS the code under the crown to 20966 within the Promo period.

#### **ELIGIBILITY**

- 3. This promotion is open only to Nigerian residents excluding employees of Diageo/ Guinness Nigeria Plc, their families and any agencies or anyone professionally connected to the Promotion. Entrants must be aged 18 and above. Proof of age and proof of purchase may be required to validate entries.
- 4. The mobile numbers on MTN, Glo, Airtel and 9mobile networks are eligible to participate in the Promotion. Entries from other networks outside the above mentioned networks shall not be accepted but may be charged by the service provider for which Guinness shall not be liable.
- 5. A Participant is deemed to have entered the Promotion upon sending an SMS to the unique code "20966".

# **HOW TO ENTER/PARTICIPATE IN THE PROMOTION**

- 6. To participate, a Participant must do the following:
  - i. Buy a promotional bottle of Orijin RTD. Open the bottle and check under the crown cork to see a unique code.
  - ii. SMS the unique code to 20966 e.g. Send 'Orijin 'Reward Code' Name' to '20966'
  - iii. Each SMS is FREE



- iv. Each unique code stands a chance of winning instant airtime or instant cash prize as specified in Section 10 below.
- v. All Participants are also able to participate in the social media competition referred to in Clause 11 for a chance to win N1,000,000 (One Million Naira) cash prize, subject to Clause 10(b) below.
- 7. Guinness will respond with a message confirming the status of the entry and the corresponding instant prize reward. Entries shall be considered invalid without a confirmation response from Guinness.
- 8. Each Participant shall not exceed a daily limit of 5 entries. In such a case, the 6th submitted code will not be used by the system and the Participant will be informed that they are able to use the code again the following day, however there will still be a N4 SMS charge. A day is measured from 12.01am to 12midnight. Participants are advised to drink responsibly.
- 9. Guinness is not responsible for any printing or typographical errors in any materials for registration, submissions that are illegible, incomplete, lost or misdirected, fail to enter into the processing system, or are processed, reported, or transmitted late or incorrectly or are lost for any reason including electronic, computer, telephone, paper transfer, mail system, human or other error; including inability to access any website associated with the Promotion. Proof of submission shall not constitute proof of receipt by Guinness.

#### THE PRIZES

- 10. Winning Instant Prizes
  - a. Winning Instant N50 Airtime- All valid entries stand a chance of winning instant N50 airtime. N50 airtime winners will receive an SMS notification indicating their prize and the winner's MSISDN is credited with N50 airtime automatically. The Promoter will endeavor to distribute airtime prizes within 5 minutes of confirmation of the winning entry however this is dependent on the Mobile Network Operators; if the MNOs are experiencing over capacity, then the ability for the Promoter to distribute airtime within that time period could be delayed and this will be outside of the Promoters' control for which the promoter shall not be held liable.



- b. Winning Instant N5,000, N10,000, N30,000, N100,000 and N200,000 Cash Prize All valid entries stand a chance of winning instant N5,000, N10,000, N30,000, N100,000 and N200,000 cash prize. Winners of these cash prizes will emerge weekly from a random system selection throughout the duration of the promotion. Winners will receive an SMS notification indicating their prize with an accompanying Paycode. The PIN for the Paycode transaction is then sent via another SMS to the winner's MSISDN. The winner is expected to use the Paycode and PIN on any ATM Nationwide that offers Paycode cardless withdrawal services to withdraw their N30,000, N100,000 or N200,000 cash. The Paycode and PIN is valid for only 7 days after issuance, after which it cannot be used to make a cardless withdrawal and this will be outside of the Promoters' control for which the Promoter shall not be held liable. N5,000, N10,000, N30,000, N100,000 and N200,000 cash prize winning codes and winners will not be eligible to participate in the social media competition/voting for the N1,000,000 prize.
- 11. One Million Naira Cash Prize— In the 1st month of the Promotion, a competition will be run on Orijin social media handles and the response with the highest number of likes as at 11.59pm on 15 March 2019 will be declared the winner of a N1,000,000 cash prize subject to the provisions of Clause 3. Also in March 2019 another competition will be run on Orijin social media handles and the response with the highest number of likes as at 11.59pm on 30 April 2019 will be declared the winner of another N1,000,000 cash prize subject to the provisions of Clause 3. Winners will be contacted to submit bank details for the transfer or presented with a pre-loaded debit card— no physical cash will be exchanged. The bank details provided by the winner must correspond with the name of the winner; failing which such winner will be disqualified and forfeit the prize money without any liability to Guinness.

# PRIZE AVAILABILITY

12. All prizes are subject to availability at the time redemption is made and the winners details are delivered to the Promoter. The Promoter reserves the right to cap or amend the prize structure as it deems fit with no liability whatsoever.



- 13. All prizes are non-exchangeable, non-transferable, and not redeemable for other prizes (in whole or in part). The Promoter reserves the right to offer an alternative prize, for any reason and without prior notice to the Participant nor liability to the Promoter.
- 14. If alternative prizes involve manufactured items, they shall be subject to the manufacturer's terms and conditions for warranty, service and maintenance, and the Promoter does not accept any responsibility for them. In particular, prizes are provided by the Promoter "AS IS" without warranties of any kind, including warranties of merchantability, satisfactory quality, non-infringement of intellectual property, or fitness for any particular purpose.

## **SOCIAL MEDIA COMPETITION FORMATS**

15. As specified in Clause 11, a social media competition will be run in February/March and in April 2019 and the submission with the highest number of likes will win N1,000,000 cash prize. One winner will emerge from each session with a cumulative total of two winners. Once a winner is selected he/she will be contacted via his/her social media handle and via telephone by the representative of the regulatory agency and/or a representative of Guinness. The cash prize of N1,000,000 (One Million Naira) can only be won once by a Participant irrespective of the phone number selected (in cases of multiple sim numbers used by a Participant in the Promotion) or the number of entries in the social media competition. If a winner cannot be contacted within 3 days of the selection and announcement of the winner, or same winner selected using different sim numbers, the Promoter reserves the right to pick an alternative winner with no liability to the Promoter. - 28. The Promoter accepts no responsibility for any damage, loss, liabilities, injury or disappointment incurred or suffered by you as a result of entering the Promotion, not being able to enter into the Promotion or accepting or not accepting any prize.
- 29. All information is correct at the time of publishing. In the event of any inaccuracy or any discrepancy between the print and online versions, the online version shall prevail over the print version.



- 30. Severability- Each of the provisions of these Terms and Conditions apply to the maximum extent permitted by applicable laws. If a court holds any provision of these Terms and Conditions to be illegal, invalid or unenforceable, the rest of these Terms and Conditions will remain in effect and these Terms and Conditions will be amended to give effect to the eliminated provision to the maximum extent possible.
- 31. Laws The Promotion shall be governed by and interpreted in accordance with the laws of Nigeria.
